The Board agreed that since these trees are leaning towards the building, they should be removed soon. Elaine stated that Bill Collins had said that the best time to bring in the heavy equipment would be after the first frost as the ground would have hardened by then. Sue and Marian also mentioned the tree behind their unit that needs to be pruned back. Elaine will have Collins address the tree when he does the other work.

A motion was made by Sue Mulhearn, seconded by Marian Gynan to approve the quote to have the trees removed as soon as the ground has frosted over.

The motion passed, all in favor.

**Interior Door Painting –** Dennis will schedule for winter. Table until next meeting.

**Circulator Pumps –** The pump in bldg. #2 has been replaced. Bldg. #3 has a temporary replacement until the new circulator pump is installed in the near future. Al Terry completed the service on the burners the week of October 9<sup>th</sup>.

**Vehicle Checks –** Vehicle checks will be conducted at random times to see if negligent vehicle owners can be tagged.

**Electric Invoice** – Elaine informed the Board that she made the final payment of \$4,950.00 to Sentry Roofing for the electrical work in the attics.
